PROGRAM OVERVIEW

The Putnam County Community Foundation (PCCF) Board of Directors guides the organization's grantmaking priorities and strategies to ensure grant funds can leverage the greatest good. Their guidance informs the work of the Grants Committee which oversees the Community Impact Grants program, a competitive funding program which seeks to meet community needs through broad, flexible grantmaking. Grants awarded through the Community Impact Grants program are funded by PCCF's Community Impact funds, unrestricted endowments, designed for the general benefit of the community. The Committee reviews grant applications from eligible organizations on an annual basis and recommends grant awards to the Board of Directors for approval.
